POLICIES & WAIVER

REGISTRATION: Submission of a registration form does not guarantee a space in class. If registration is received without payment, space will be held in the class for five (5) business days or until three (3) days prior to the start of class. Payment for registrations submitted electronically may be made on-line through our secure PayPal portal or through the postal system by check or money order. Once registration and payment are received, confirmation will be sent to the student.

RETURNED CHECKS, CANCELLATIONS & REFUNDS: There is a returned check fee of \$35 plus any fees incurred by The Companionable Canine Ltd. as a result of the returned check. If a check is returned, payment must be made by cash, money order, or credit card.

Full refunds will be issued if notice of cancellation is received at least seven (7) days prior to the date of the first class meeting. Cancellations received less than seven (7) days prior to the date of the first class meeting will be refunded minus a \$25 processing fee. Cancellations received after the first class meeting but prior to the start of the second class may receive a 50% refund. There will be no refunds made after the second class

meeting.

PROOF OF VACCINATION: Proof of the following vaccinations is required prior to the first class meeting: Rabies; Distemper, Hepatitis, Leptospirosis, Parvo, Parainfluenza (DHLPP); Bordatella. Use of heartworm prevention is also required. A copy of the vaccination record can be submitted through the postal system or scanned and sent by e-mail to registration@compk9.com.

WAIVER: Waiver, Release and Assumption of Risk

As the legal owner and guardian of my dog, I do hereby waive and release The Companionable Canine Ltd. and Godfrey's Welcome to Dogdom LLC and their agents, officers, and employees from any and all liabilities of any nature. I agree to take complete responsibility for the actions of my dog and myself before, during, and after class. At no time will the instructors of this class or agents, officers, or employees of The Companionable Canine Ltd. or Godfrey's Welcome to Dogdom LLC be held liable or responsible for the actions of me, my dog, or and other person who accompanies me to class.

I understand that my participation in any of The Companionable Canine Ltd.'s dog training classes or private training is not without risk to myself, my dog(s) or any family member or guest who might be present at such function. Said risks may include illness, falls, bites, injury through contact with other participants, their dog(s), or the surroundings where training takes place. I understand that participation by myself, family members/guests, and my dog in training is voluntary and hereby expressly agree to indemnify and hold harmless The Companionable Canine, Ltd. and its employees, owners, and agents of and from any and all claims, causes of action, losses, damages, judgments, costs, or expenses, including attorney's fees, which in any way arise from my or my family members or guests acts, omissions and/or negligence, irrespective of whether the acts, omissions and/or negligence of The Companionable Canine Ltd., its employees, owners, or agents contributed to the loss.

Some dogs to which I might be exposed may be difficult to control and/or aggressive towards other canines, and may be the cause of injury even when handled with care. In addition, it is my responsibility to keep my dog current on vaccinations, but I recognize that dogs may still be susceptible to various diseases in spite of the vaccinations. I expressly assume the chance of such damage or injury while attending any training class or activity sponsored by The Companionable Canine Ltd.

The Companionable Canine Ltd. makes no representations, guarantees, implied or expressed promises that any training received will cure a dog of any dangerous propensities. It is fully understood that regardless of the training received by the animal, a dog always possesses the capability to bite. Additionally, I understand that no guarantees are expressed as to the result or outcome of training.

I hereby waive, release, discharge, and covenant not to sue The Companionable Canine Ltd., its owners, employees, and agents from any and all liability of any nature, for injury or damage which I, my dog, or any family member may sustain, including specifically, but without limitation, any injury or damage caused by the action of another dog or participation in the foregoing activities. I specifically understand that I am releasing, discharging and waiving any claims or actions that I may presently have or in the future have, for the negligent acts or other conduct by the owners, employees, or agents of The Companionable Canine Ltd..
